
Norway Spruce will be back this year after not being offered in 2023. A new variety being offered is the Butternut Tree (pictured above), this is a broad round tree that can be as much as 60 feet wide and offers plenty of shade. It is a slow growing tree that adds less than 12 inches per year. It needs moist, well-drained soil to grow with full sun. The rest of the varieties are ones that we have sold in the past.

## **Registration Now Open for Civic Leadership Academy 2023**

Free public course gives inside look at government departments with discussions and tours hosted by officials

Peoria County – Peoria County announced today that the Civic Leadership Academy (CLA), an annual program held each fall in conjunction with the City of Peoria, will be returning in September 2023. With an aim to help locals understand governmental functions, the free program includes a weekly session that takes place at either a County or City government facility and usually involves a presentation, tour, and time for questions and answers.

#### Making Farm Reconstitutions

When changes in farm ownership or operation take place, a farm *reconstitution* is necessary. The reconstitution — or recon — is the process of combining or dividing farms or tracts of land based on the farming operation.

To be effective for the current Fiscal Year (FY), farm combinations and farm divisions must be requested by **August 1 of the FY** for farms subject to the Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC) program. The 2022 Reconstitution request period for ARC/PLC has ended, but reconstitution requests for 2023 can begin to be processed Oct. 1, 2022. A reconstitution is considered to be requested when all of the required signatures are on FSA-155 and all other applicable documentation, such as proof of ownership, is submitted.

Total Conservation Reserve Program (CRP) and non-ARC/PLC farms may be reconstituted at any time.

The following are the different methods used when doing a farm recon:

Estate Method — the division of bases, allotments and quotas for a parent farm among heirs in settling an estate

#### Designation of Landowner Method —

may be used when (1) part of a farm is sold or ownership is transferred; (2) an entire farm is sold to two or more persons; (3) farm ownership is transferred to two or more persons; (4) part of a tract is sold or ownership is transferred; (5) a tract is sold to two or more persons; or (6) tract ownership is transferred to two or more persons. In order to use this method, the land sold must have been owned for at least three years, or a waiver granted, and the buyer and seller must sign a Memorandum of Understanding

DCP Cropland Method — the division of bases in the same proportion that the DCP cropland for each resulting tract relates to the DCP cropland on the parent tract

**Default Method** — the division of bases for a parent farm with each tract maintaining the bases attributed to the tract level when the reconstitution is initiated in the system.

#### **Update Your Records**

FSA is cleaning up our producer record database and needs your help. Please report any changes of address, zip code, phone number, email address or an incorrect name or business name on file to our office. You should also report changes in your farm operation, like the addition of a farm by lease or purchase. This includes updating records to show the proper succession of deceased owners. You should also report any changes to your operation in which you reorganize to form a Trust, LLC or other legal entity.

FSA and NRCS program participants are required to promptly report changes in their farming operation to the County Committee in writing and to update their *Farm Operating Plan* on form CCC-902. Reporting your updates earlier in the year allows us to update your information more completely and reduces complications created by waiting until contract signup or acreage reporting to make those updates.

# **Submitting Production Losses for Disaster Declarations**

Farmers and ranchers know all too well that natural disasters can be a common, and likely a costly, variable to their operation. The Farm Service Agency (FSA) has emergency assistance programs to provide assistance when disasters strike, and for some of those programs, a disaster designation may be the eligibility trigger. When natural disaster occurs, there is a process for requesting a USDA Secretarial disaster designation for a county. You can play a vital role in this process.

If you have experienced a production loss as a result of a natural disaster, you may submit a request to your local FSA county office for your county to be evaluated for a Secretarial disaster designation. Once a request is received, the county office will collect disaster data and create a Loss Assessment Report. The County Emergency Board will review the Loss Assessment Report and determine if a recommendation is sent forward to the U.S. Secretary of Agriculture for the designation.

# Adjusted Gross Income Forms (AGI's)

The 2018 Farm Bill requires the implementation of an average AGI limitation for payment eligibility, (\$900,000). This limitation provision applies to most programs administered by the Farm Service Agency (FSA) and Natural Resource and Conservation Service (NRCS). All persons and legal entities requesting certain program payments, either directly or indirectly, are subject to the AGI limitation provisions. Participants in programs subject to AGI rules must annually certify their eligibility to receive program benefits. IRS requires written consent from the individual or legal entity to provide USDA verification of compliance with AGI limitation provisions. The annual certification is made possible by completing the CCC-941 form, Average Adjusted Gross Income Certification and Consent to Disclosure of Tax Information. The AGI limitation takes into consideration the 3 taxable years preceding the immediate preceding tax year for which payments/ benefits are being requested. If you have not filed your annual AGI, please contact the Peoria County USDA Farm Service Agency at (309) 671 7040 ext. 2 so that we may assist you in getting this completed.

#### **Direct Deposit/Hardship Waiver**

If you are currently receiving your FSA/CCC program payment by paper check, or if you have just become eligible to begin receiving an FSA/CCC payment, you should elect to receive your payment by direct deposit through the financial institution of your choice. FSA/CCC makes payments electronically through a program called direct deposit, which is safe, convenient and a reliable way to receive your FSA/ CCC payment directly to your bank account. Hardship waivers are available if payment by EFT would impose a hardship because of a physical or mental disability, the individual faces a geographic, language or literacy barrier to receiving payment by EFT and/or payment by EFT would impose a financial hardship. If you are still receiving paper checks, please contact the Peoria County USDA Service Center at (309) 671 7040 ext. 2 so that we may assist you in either setting up your direct deposit for FSA/ CCC payments or filling out a hardship waiver to continue receiving paper checks.

- **⇒** Electronic payments are faster:
- Paper checks take days to arrive in the mail and can require additional time to cash or deposit the check.
- ⇒ Electronic payments are cheaper:
- Every check that is converted to an electronic payment saves the American taxpayer and allows the government to save tens of millions of dollars.

# CRP Mid-Contract Management and CRP Maintenance is Required

Participants in the Conservation Reserve Program (CRP) are responsible for maintaining the acreage under contract to the minimum specifications and acreages as required by their conservation plan and supporting documents. This includes not only controlling excessive weeds, invasive species, and trees in grass practices, but completing required management on CRP practices as scheduled in your conservation plan.

### 2024 Peoria County Farm **Bureau Photo Calendars**



Peoria County residents are encouraged to stop by the Farm Bureau office and pick up a FREE 2024 Farm Bureau photo calendar after November 15. The Farm Bureau's Public Relations Committee is sponsoring the printing of 2000 calendars which will feature farm-related pictures that were submitted by members for this year's photo contest. The calendar will debut at the County Annual Meeting on November 11.

It is an 8.5" X 11" wall calendar with space to write birthdays, anniversaries, meeting reminders or other scheduled events.

The calendar will also highlight local events such as Peoria County Farm Bureau programs and meetings, Soil and Water District programs, USDA Crop Reporting Dates, Farm Service Agency deadlines, and other agriculture related meetings and activities.

#### 2024 Peoria County Plat Book Coming

A new 2024 Peoria County Plat Book will be available by December 1 of this year at the Farm Bureau building in Peoria. The Peoria County Farm Bureau has teamed up with Mapping Solutions to create the new book. It will feature updated landowners and acreages for the 19 townships in Peoria County. Unique to this book will be historic 1923 township plat maps next to the newly updated plat maps. The historical maps will replace the satellite maps that were printed for each township in the 2018 book.

## **Citrus and Nuts Coming**

Peoria County Farm Bureau will be offering fresh Oranges, Grapefruit, Clementines, a Holiday Gift Basket, and nut products to members beginning in mid October. Orders will be taken until Wednesday, November 15 and pick up will be at the Peoria County Farm Bureau building on Wednesday, December 13. The oranges and grapefruit are being sold in 20 pound and 40 pound boxes. Although the size of the citrus varies each year, there are typically 50-60 oranges and 30 to 40 grapefruit per 40 pound box and 100 clementines in a 20 pound box. Clementines are a variety of the mandarin orange. They are sweet, peel easy, and seed-







## **FALL FISH SALE 2023**

Saturday, October 7, 2023

The Fall Fish Sale is now in progress and many varieties and sizes of fish are available. The Fisheries Biologist with the IL Dept of Natural Resources recommends the following stocking rates for ponds with no fish: 750 bluegill; 250 redear; 100 channel catfish and 100 bass. All rates are per acre of water surface and are fingerling fish (1-3"). By initially stocking the correct number of fingerlings, rather than releasing a smaller number of adult fish, a lake will produce sport fishing in less time and without stunting. Triploid Grass Carp are available again. Recommended stocking is five (5) grass carp to an acre of surface grass or algae in a pond.




