AN ORDINANCE levying taxes for all assessment purposes for the PEORIA COUNTY SOIL & WATER CONSERVATION DISTRICT, Peoria County, Illinois, for the year 2022

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF PEORIA COUNTY SOIL & WATER CONSERVATION DISTRICT, PEORIA COUNTY, ILLINOIS, as follows:

SECTION 1: That the sum of **fourteen thousand four hundred** (\$14,400) is hereby levied upon all property subject to taxation with the PEORIA COUNTY SOIL & WATER CONSERVATION DISTRICT as property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the PEORIA COUNTY SOIL & WATER CONSERVATION DISTRICT as required by statute, for the year **2023**.

SECTION 2: The amount levied is necessary to cover the SWCD's liability expenses as follows:
